#### Call to Order

## Information from VCU A/P Faculty Issues Panel Discussion

Ellen Plummer and Karen Saunders were invited to serve on a panel at VCU. The focus was an opportunity for advancement and growth, specifically at Virginia Commonwealth University. Karen noted that our A/P Faculty at Virginia Tech are in a much better place than others. There is a need for professional development for A/P faculty.

Karen and Ellen would like to host a speed networking event, similar to one they attended in Roanoke, which would offer A/P faculty a chance to meet 30 professionals in 3 rounds. ## **Opportunity for CAPFA to help with Faculty Handbook**

CAPFA will assist Ellen Plummer with realigning items in the policies and procedures of the Faculty Handbook in the spring. The faculty rely on CAPFA when they file a grievance or complaint. Ellen Plummer, Jack Finney, Hal Irvin, Rodney Irvin, and Jennifer Hundley had the opportunity to meet and discuss the grievance process for faculty and found that there is an opportunity for additional adjusting in the grievance process. This group may need to call on CAPFA for assistance or those who have served on a grievance panel in the past. Ellen Plummer will be working on this during the spring and would like to have this completed by the end of June. On average there is usually one grievance per year.

### **Other Items from Commission Members**

There is interest in the Commission on Student Affairs and the Commission on Faculty Affairs to bring forward an adjustment to Policy 1025. The change is to add the language gender identity and gender expression. CAPFA should be a key partner in the discussion and resolution. The hope is to bring it to University Council in the fall.
