### Legal Resources – New Benefit – Yohna Chambers

Yohna Chambers, Assistant Vice President for Human Resource Operations, presented an overview of the new legal benefit provided by Legal Resources. For the employee, the cost is \$8.25 per pay period and the entire household is covered. During the recent open enrollment, 615 employees enrolled in the program. Listed below are some of the items that are covered at no additional cost:

- Legal advice and consultation
- Tenant dispute with landlord
- District court representation in a civil action
- Review of a financial contract or lease
- Traffic court representation (including first offense DUI)
- Will preparation
- Uncontested divorce representation
- Uncontested domestic adoption (including name change)
- Purchase, sale or refinance of primary residence
- Defense of child in juvenile court (misdemeanor)

Open enrollment for this benefit will be held once a year.

# **Grievance Policy Updates**

Amy Hogan distributed the proposed changes to the Grievance Policy and Procedures for Administrative and Professional section of the Faculty Handbook. She explained that most of the changes evolve around the issue of grievability. A grievability panel will be convened during Step 1 of the process to determine if the issue is grievable.
