2. <u>Self-plagiarism: Update from COR and CFA representatives meeting on October 28 to discuss Research Policy 13020 (Policy on Misconduct in Research).</u>

Dalloul explained that he and Wat Hopkins met with two representatives of Commission on Research (COR) to discuss changes to the university plagiarism document. During the meeting CFA members reviewed the proposed changes. CFA members suggested to replace the second to last sentence under Section 2.2 Activities Covered with "This includes self-plagiarism, which occurs when and an author reuses or presents substantial parts of his or her own published work or data as new without providing appropriate references to the previous work."

3. <u>CFA 2014-15A</u>: Resolution to approve the Department of Biomedical Engineering and Mechanics.

CFA members completed a second reading of the resolution to approve the new department name and reviewed the explanation that Stefan Duma, Department Head of Biomedical Engineering and Mechanics provided to Finney. The explanation discussed the distinction between Mechanics and Mechanical Engineering. Finney added that the title of the resolution was changed to include the new department name to ensure that this document would appear in online searches. Motion for name change was voted on and passed by CFA members.

4. Representation/nomination to serve on nominating committees for a) Academy of Faculty Service and b) University Distinguished Professor.

Dalloul asked for two CFA members to represent CFA on the Academy of Faculty Service and University Distinguished Professor committees. Abbas will be representing CFA in the Academy of Faculty Service committee and Hopkins in the University Distinguished Professor committee.
