# **Graduate Student Assembly (GSA):**

- Had delegate cabinet meeting
- Fees committee had forum. The committee is still working with the administration to discuss possible solutions.
- Health insurance committee looking at new provider options
- A new health advisory group is discussing ways to unite Schiffert and Cook Counseling.
- Child Care Committee had a luncheon and developed goals and a timeline.
- Transportation & Parking Committee is working with the SGA. They are examining the issue of sustainability and seemingly contradictory practices. The groups would like more bike racks on campus. There was some concern expressed about selective "edits" on minutes.

Graduate Honor System (GHS): No report.

<u>University Library Committee (ULC)</u>: Dr. Hitchingham reported that the committee had met and discussed (1) collection management and (2) a new product to be introduced called "Summon<sup>TM</sup>", a web-search tool.. Minutes from the September 24<sup>th</sup> meeting will be on the November 17<sup>th</sup> agenda.

<u>University Council</u>: At the November 1<sup>st</sup> meeting Dr. Redican presented the discontinued degrees for a first reading.

## Update on Interdisciplinary Graduate Education: Dr. Karen DePauw

Dr. DePauw announced that she had sent out the initial call-for-proposals for the new Interdisciplinary Graduate Education Programs. She reiterated that this is part of the university's strategic plan to encourage and promote more interdisciplinary graduate education initiatives. The provost has provided some funds to help get the program started. Dr. DePauw noted that additional resources will be needed from the provost to fully implement the program. Within three years, the plan is to have 10 new disciplinary programs. This year's awards, due to the restricted timeline, will favor faculty groups who have already been working on developing interdisciplinary programs. Faculty will be notified by late January so that programs can begin enrolling students. This spring, a second round of proposals will be solicited for a fall start date. Interdisciplinary proposals selected for fall will be-announced by late January so that faculty have time to recruit students to the programs. There is work in process on full credit accounting for courses team-taught or taken across disciplines.

Some concerns were expressed about accurately counting student enrollment as well as assigning credit value for courses as well as employability of graduates. Ms. French described her need for an interdisciplinary background in order to pursue her career goals.

Part of the funding plan is to reallocate some of the PHD2010s to interdisciplinary programs. Dr. DePauw feels the impact of reassigning PhD 2010s on colleges will be minimal. It is likely that faculty will recruit both new and existing students into the programs.
