### **Other Reports**

Graduate Student Assembly (GSA):

Ms. Laura Freeman reported that at the last delegate meeting,

- (1) A resolution was passed which affirms their support for diversity in graduate education
- (2) A resolution was passed which supports graduate student input into the tenure review process
- (3) A snow-boarding winter event is planned
- (4) A health insurance meeting was held [December 2] and a number of areas of concern were identified:
  - Higher maximum benefits
  - Higher prescription limit
  - Lower deductible amount
  - Northern Virginia graduate students getting access to VT graduate student health coverage [Jim Lane, GM Southwest, will provide information to students which will allow Northern VA students to seek medical assistance without first seeking a referral from the VT health system]

 Web-based health coverage information will be updated to assist graduate students in their decision making, e.g., deciding when they should or shouldn't go to Schiffert, how Schiffert can help, etc. Nancy Feuerbach will scan the medical plan brochure and post it on Blackboard

## Graduate Honor System (GHS):

Mr. James Freeman asked the commission if any questions were generated from the November 19<sup>th</sup> report [given by Ms. Laura Freeman].

Mr. Freeman reported that the Constitution Review Committee is continuing to meet. He expressed his appreciation for the efforts that Ms. Monika Gibson, Director of Student Services, has given to the committee. Mr. Freeman hopes to have a draft to present to the commission by early February.

## University Library Committee (ULC):

Dr. Eileen Hitchingham reported that the ULC met before Thanksgiving and (1) welcomed new graduate students and (2) talked about the effect possible budget cut-backs could have on library resources. At the commission's request, she elaborated on the impact budget cuts have had – and will have – on library operations.
