<u>Degree Requirement Standards Criteria and Academic Policy (DRSCAP)</u>: The commission discussed the below change to existing procedures, and how changes would be implemented.

Graduate students who are receiving a full-time assistantship (GRA, GTA, GAs) are expected to work an average of 20 hours a week on the assigned assistantship duty. Graduate students receiving full-time assistantships are not prohibited from seeking additional employment; however, when such additional employment is accepted students must notify the Graduate School and their advisor. For international students any additional employment must be in compliance with their current visa status.

Dr. DePauw will ask VT Legal Counsel to review language changes. The DRSCAP committee will incorporate discussion items into a revised statement.

# **Other Reports**

### Graduate Student Assembly (GSA):

At the last meeting, the GSA talked about

Distance Delivered Graduate Courses: Dr. DePauw asked the commission to take a look at the process by which we move courses to distance deliver and quality assurances that we use. This should be done in concert with IDDL. Commission members who volunteered to work on this issue are: Dr. Tom Grizzard, Dr. Kumar Mallikarjunan, Dr. François Elvinger, Dr. Mark Halsey, and Ms Nasim Sabounchi.
