Committee Reports

Graduate Curriculum Committee (GCC): The minutes from November 10th were approved.

Degree Requirements, Standards, Criteria, and Academic Progress (DRSCAP):

Dr. Pat Hyer, co-chair of the committee re-writing the Conflict of Interest (COI) policy, discussed the first draft of the replacement sections for the revised policy 13010 (dated 10.28.11). In particular, the commission discussed the sentence in section 2.2 from the Graduate School catalog, "Graduate School policies prohibit faculty members from serving as an advisor or committee member for individuals with whom they have a personal relationship." There was some concern that the phrase "personal relationship" needed careful and clear definition. Dr. Hyer noted that the entire COI policy had a definition section. She suggested that better terms to describe relationships would be "family" and "partner", because the law supporting this policy defines "family". The document the commission was reviewing contained excerpts from the main document that pertained directly to Graduate School policy.

The commission supported the transparency a signed agreement would afford a student, but some commission members expressed concern that students with limited funding options could feel pressured into signing an agreement if no other funding options were available. The agreement would be signed either prior to the start of the assistantship, or soon thereafter.

It was decided that final word-smithing would be best settled out of committee and several CGS&P members volunteered to work with Dr. Hyer to reach the best phrasing for this policy.

Dr. Copenheaver asked commission members to e-mail comments and suggestions to Dr. Hyer.

<u>Graduate Student Assembly Report (GSA)</u>: Ms. Shaimaa Abdallah distributed flyers for the Research Symposium scheduled for March 28th, 2012. Abstract submissions are accepted from December 1st to December 8th, 2011.

<u>Graduate Honor System (GHS)</u>: Ms. Tara Frank announced one new case. She anticipates that this case will be resolved via facilitated discussion.

<u>University Library Committee (ULC)</u>: The library will be initiating new services:
