It was announced that the tuition and fees set by the BOV included:

- 1. 4.9% increase in tuition and fees for Virginia resident undergraduate rates
- 2. 5% increase in tuition and fees for Non-Virginia resident undergraduate rates
- 3. 4.9% increase in tuition and fees for Virginia resident graduate rates
- 4. 5.7% increase in tuition and fees for Non-Virginia resident graduate rates
- 5. 3.9% increase in housing rates
- 6. **7.9%** increase in dining rates

6. <u>Reports</u>

a. <u>Virginia Cooperative Extension (VCE)</u>

Mike Lambur announced the new VCE colors and graphics and passed around some of the letterhead examples (see attached). The maroon indicates the VT presence and the blue represents Virginia State.

There will be a professional development event offered to the 220 agencies around the state where there will be a specialist-agent exchange. The hope is to match up some folks which will spend a day in respective units.

The Virginia Extension Service Association (VESA) will be having their annual meeting May 15th for professional development.

Lonnie Johnson, Senior District Director in Richmond is introducing some networking and relationship building events. Six (6) agents in each district will train other agents, the kickoff will occur in July.
