1. <u>Welcome and Introductions</u>

2. Agenda Approval

- 2. 5 Regional Centers-CESA; Latin America; Africa, Caribbean Center at Punta Cana; India
- 3. Priorities for UCIA-address challenges for the faculty in putting together Study Abroad Programs and faculty support for the 5 centers.

Engaged scholarship

- Constructed through community partnership(s)

Like other forms of scholarship

- Advances the state of knowledge
- Can be replicated or elaborated
- Can be documented, disseminated, reviewed, discussed, and critiqued

Measurement

- Impact (economic, social, and environmental)
- Not solely upon creation of a product
