# I. Call to Order and Approval of the Agenda

## II. Presentations

Virginia Tech received a record number of applicants for the student representative positions for the Board of Visitors. Semi-finalists have been selected and will be coming to CSA at the next meeting to introduce themselves.

Virginia Tech is hosting the VACURH 2016 Conference. At VACURH 2015 this year, Virginia Tech won School of the year, Ken Belcher won Advisor of the Year, Kylie Gilbert won the VACURH Service Award and Jackie Fisher won Student of the year.
