IV. New Business

a. Graduate Student Assembly Constitutional Changes (First Reading)

Mr. Greg Purdy presented the proposed new GSA Constitution, stating that the current GSA Constitution is unclear on the internal structure of the organization, and is unable to ensure sustainable operations, as it is ineffective guidance to fulfill the mission of the GSA to serve graduate students at Virginia Tech.

b. FERPA Exceptions Discussion

Mr. Joe Edens explains that Wanda Dean, the Vice Provost of Enrollment and Degree Management, has asked the Commission the opinions on making Virginia Tech e-mail addresses automatically public under the FERPA Exception list. The Commission explains feelings of concern that information could be sold if this information was to be made public, but overall the Commission feels that a majority of students are unaware that their records can be marked as confidential or not, so regardless of the decision, members of the Commission feel that this ability to mark confidentiality should be better communicated to the students. After discussion, the majority of the commission believes that home phone numbers and addresses should be automatically confidential, while e-mail addresses should not.

The Student Budget Board Policy Committee is trying to make major changes to the SBB Policy, as it does not currently state structure very well. There is currently very little interaction between CSA and SBB, so an idea was discussed about possibly having the student chair of SBB sit as an ex-officio member of CSA.
