Call to Order

Title IX Focus Groups

Representatives for Title IX introduced themselves and stated their titles:

The research team members explained the focus group is being conducted to find out what information students know about Title IX, reporting and resources, and the investigation process at Virginia Tech. The meeting is meant to be reflective and to learn where improvements can be made.

The commission was advised the discussion is completely voluntary, no names are being recorded, and to feel free to speak openly. Further, if anyone feels uncomfortable at any time during the discussion, they are welcome to leave, no questions asked. Research team members asked for input on several questions including:

- Who is mandated to report and who is not?
- Who would you talk to if you felt someone violated Title IX?
- How do you expect the university to respond to a Title IX violation or sexual harassment?
- How can the university help those involved feel safe?
- What final outcomes do you expect?
- What can you expect to happen to someone who is responsible for committing an act of violence?
- Do you have suggestions on how we can educate students of their rights?

In closing, it was suggested to the commission that as they engage with their organizations and peers, if they think of ways in which to communicate with their groups, let the research team members know.
