1. Approval of agenda

3. Old Business

Commission on University Support Proposed Resolutions

Discussed two potential resolutions:

- Resolution to Eliminate the Commission on University Support
- Resolution to Suspend the Commission on University Support

The Staff Senate voted to reject both proposals based on potential future need. Other committee members agreed that the Commission is valuable since it provides transparency in university governance and an audience for community concerns regarding policy issues. A concern was expressed regarding lack of community input on issues/areas under charge of the CUS. Although the committees could go through different Commission(s) if CUS was disbanded, the process may become more complex by going through more than one Commission to reach University Council.

Members discussed the core charge of the Commission, including what issues are appropriate for the Commission, associated committees, and/or administrators to address. Most issues addressed by the Commission are "administrator-level" policies. The consensus was that the

governance process is in place to ensure that the voices of university community members are heard, not to create policy in governance commissions and committees.

Bradley Scott moved that the Commission not move forward with either resolution. The motion was seconded and passed with a vote of 7 (for), 2 (opposed), 2 (abstained).

Transportation and Parking Resolution Update

The Transportation and Parking Committee is working on several resolutions:

- Auxiliary/Event Visitor Parking Charges
- Tiered Parking Fee Structure for Faculty/Staff
- Review of MOU between Athletics and Parking Services
- Bicycles on Sidewalks

Note: The Vice President of Administrative Services reminded Chair that the Transportation and Parking Committee can only recommend administration review parking rates, not establish policy for rates.

Election of Vice Chair

Members in attendance who are eligible to serve as Vice Chair did not volunteer to serve; therefore, this item was deferred to next meeting.

Election of Representative to Transportation and Parking Committee

Leslie O'Brien volunteered to be representative to the Commission's representative to the Transportation and Parking Committee.
