## **University Curriculum Committee for Liberal Education**

Rachel Holloway presented the University Curriculum Committee for Liberal Education Resolution to Update Membership of the University Curriculum Committee for Liberal

Education (Resolution 2009-2010 C) for second reading with a friendly amendment. It was stated that two additional people, the Director of Academic Assessment and an AP Faculty Representative for the University Libraries will be added to the membership. The motion to approve the University Curriculum Committee for Liberal Education Resolution to Update Membership of the University Curriculum Committee for Liberal Education (Resolution 2009-2010 C) for second reading with a friendly amendment passed unanimously.

#### **Other Business**

Wanda Dean introduced Dr. Peter Doolittle and Dr. David Kniola who presented a report on the new University ViEWS requirements and the Academic Program Review process. Dr. Doolittle stated that the Center for Instructional Development and Educational Research (CIDER) and the Office of Academic Assessment (OAA) are working to construct an process to review all departments ViEWS requirements using the existing governance process. CIDER and OAA have determined that any changes to ViEWS requirements that are less then 20% can be approved administratively by the department while ViEWS requirements with a greater than 20% revisions will be reviewed through the college curriculum committee and then through governance just as course proposals do. Dr. Doolittle stated that that these guidelines will be implemented starting in Fall 2010. Dr. Kniola stated currently, academic programs are reviewed on a five-year cycle and that work is being done to make the Academic Program Review process more meaningful and manageable. Dr. Kniola stated that academic programs have been and will continue to be evaluated at regular intervals.

Jill Sible, Associate Dean, College of Science, moved approval of the posthumous awarding of the degree of Bachelor of Science in Biological Sciences, to Benjamin Hair, effective Spring 2010. The motion was seconded. Dean Sible indicated the request was the recommendation of the faculty of the College of Science. The student is in good standing and meets all requirements for a posthumous degree. The motion carried unanimously.

Dr. John Browder described the new teaching evaluation forms being developed with OAA and Learning Technologies. Dr. Browder stated that the Academic Task Force is going to test the new forms by asking each college to pilot fifty cases with the new template this year. Dr. Browder stated that the new form contains better questions and much more specific items, and that it was developed by using research from other universities as well as national best practices. Faculty who participate in the pilot will not be using the existing form in addition to the pilot form. There is an effort to make the evaluation more formative and less summative. The new form will include both a formative self assessment and a formative peer evaluation.
