Long requested that the Commission's Faculty Senate representatives share, for the full Faculty Senate's consideration, the need to update the Faculty Senate Bylaws regarding the required number of Faculty Senate meetings. G. Long referenced that the current Bylaws require the Faculty Senate to convene twice per semester, and felt that the bylaws should be updated to reflect a more frequent meeting schedule, in support of the governance process. The Commission's Faculty Senate representatives acknowledged this request.
