Call to Order and Announcements

The meeting was called to order at 3:00 p.m. by Diane Zahm, Chair.

Adoption of the Agenda

Resolution 2012-13.A "Resolution to Approve New Bachelor of Science Degree in Real Estate", Second Reading.

Susan Sumner, Associate Dean Academic Programs, verified corrections mentioned by the committee were included in the documents provided for the second reading. The motion to approve Resolution 2012-13.A. "Resolution to Approve New Bachelor of Science Degree in Real Estate", effective Fall 2013, passed unanimously.

Bevlee Watford raised the question of using the term "Innovation" in the name of the degree, noting concern it implies no other industry is innovative.

Susan Sumner mentioned that the proposal reads to her as a Bachelor of Science in Innovation and has difficulty linking it to Sustainable Biomaterials. Dr. Kline responded that it is "innovation" driven by Sustainable Biomaterials.

The committee suggests that the department consider renaming this degree by removing "and Innovation".

Robin Panneton expressed concerns the Design and Craftsmanship track includes only one course from the discipline. She suggests scaling down to three viable tracks.

Diane Zahm reminded the committee that the second reading will take place at the next CUSP meeting which is scheduled for Monday, October 8, 2012.
