3. Unfinished Business

Commission on Faculty Affairs CFA Resolution 2024-25G Resolution to Amend Articles V, VI, and IX of the Faculty Senate Constitution

Justin Lemkul presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed.

4. New Business

Commission on Graduate and Professional Studies and Policies CGPSP Resolution 2024-25B Resolution to Revise the Graduate Honor System Constitution Renée LeClair presented the resolution for first reading. This resolution proposes updates to the Graduate Honor System Constitution. The changes include:

- 1. Assigning research misconduct allegations to the Research and Integrity Office.
- 2. Updating language to reflect the new name of the Graduate and Professional Student Senate.
- 3. Clarifying procedures for handling cases in which a single incident or infraction is referred to the Graduate Honor System by multiple referrers.
- 4. Automatically granting preliminary review panel waivers for students who have pled guilty.

These revisions aim to align with updated terminology and streamline processes within the Graduate Honor System.

Commission on Undergraduate Student Affairs CUSA Resolution 2024-25A Resolution to Update CUSA Membership to Enhance Undergraduate Student Representation

Aarav Parikh presented the resolution for first reading. This resolution proposes changes to the Undergraduate Student Senate Constitution and University Council bylaws, specifically regarding the membership structure of the Commission on Undergraduate Student Affairs. The current requirement mandates an equal number of specific senator types (four at-large, four college, and four senators from University Chartered Student Organizations-UCSO), which has made it difficult to fill all 12 seats. Additionally, a new type of senator was recently introduced and is currently ineligible to serve on the commission under existing rules. The proposed change would require at least one senator of each type, with the remaining eight seats to be appointed by the commission chair and the Undergraduate Student Senate president, pending Senate approval.
