Diane Zahm called the meeting to order at 12:03 p.m. A quorum was present.

1. Announcement of approval and posting of minutes of 10/8/25

2. Fall Commencement Draft Timeline Review

Diane Zahm turned the meeting over to Jessie Richards from Special Events to share the draft timeline for ceremonies. It was confirmed that doors at Cassell will open for both graduates and the public at 9 a.m. Diane Zahm noted that volunteers will need to arrive, be briefed, and in place prior to doors opening. Both University and Graduate School ceremonies will be held on Friday, December 19, 2025. The university ceremony will begin at 10:30 a.m. and the graduate school ceremony will begin at 2:30 p.m.

3. Commencement Speakers Update

It has not yet been announced publicly, but it has been confirmed that Cyril Clarke will be the keynote speaker for university commencement. This will be announced publicly soon. Eryn Giegel and Janice Austin confirmed that student speakers for university and graduate school ceremonies, respectively, will be announced soon as well.

5. Volunteer Reminders

Diane Zahm announced that the call for volunteers for both university and graduate ceremonies has gone out from her office. Everyone should ensure they are completing the forms correctly and placing people in the appropriate locations for each ceremony/section. This is a Google Doc that has been shared with everyone on the Commencement Committee as well as all college contacts for commencement. All users with access can edit the document. Jessie Richards suggested that adding shift times to the document would be helpful for clarity of scheduling. The following information and needs have been shared with the colleges:

- University Ceremony
 - One marshal with regalia to lead graduates to the podium
 - One marshal with or without regalia to assist with other aspects of the ceremonies, for example, seating graduates in advance of the ceremony and directing graduates back to their seats during the ceremonies. Regalia is welcomed, but will not be required for this marshal.
 - One escort without regalia to assist with ADA services.
- Graduate Ceremony
 - One escort without regalia to assist with ADA services.
- Names and contact information for all those assisting with ceremonies will be due by December 1.

6. Special Events/Implementation Team Update(s)

No updates currently from Special Events or Implementation. Everything is on track as we get the ball rolling for logistics. Implementation Team is currently meeting bi-weekly on Tuesdays from now until December 16.

7. Further Business

Joseph Cooley (ADA) raised questions about changes or edits to the website as well as rumors that the Merryman entrance would not be used as an ADA entrance this year. He requested that the website be clear that the public should direct questions to ADA and not SSD as SSD is for students. Jessie Richards confirmed that both Washington Street and Merryman entrances remained the planned ADA-accessible entrances. Cara Walters (Athletics) added that there will be no issue for ADA guests to continue having access through Merryman as in past years. Milford Palmer (VTPD) confirmed that, as in past years, they will have an officer assigned to the Merryman entrance. Jessie Richards confirmed that ADA and SSD are being asked to review the website again to ensure that all information – especially any link which navigates away from the main commencement site – is accurate.

Kim O'Rourke reported that Title II accessibility requirements will apply to websites and live-streams and noted the extensive specifications involved. Annie McCallum shared that the communications team has been working diligently toward this goal for quite some time and the commencement site is nearly complete. Work continues on live-stream accessibility. Kim O'Rourke emphasized the complexity of ensuring accurate descriptive content for viewers with visual impairments during live-

streams and will follow up with Annie. Attendees were asked to direct any questions or concerns regarding accessibility to Annie McCallum and Jessie Richards.
