Commission on Faculty Affairs Resolution CFA 2022-23A

Resolution to Revise the Faculty Handbook Regarding Emeritus or Emerita Designation

Robin Queen presented the resolution for first reading. The goal of this resolution is to clarify some language in the Faculty Handbook as it is currently written as well as to remove some of the more procedural things out of the handbook. This change will help clarify who is eligible for emeritus or emerita status and what the path is to obtain that designation. A suggestion was made to add the executive vice president and chief operating officer as an option for final approval for administrative and professional faculty who do not work in academic affairs in within a college.

Commission on Graduate and Professional Studies and Policies Resolution CGPSP 2022-23A

Co-operative Education Program Change

Montasir Abbas presented the resolution for first reading. This resolution changes the one-credit-hour allocation for co-op to zero credit hours. This change is being made because the co-op experience is not

monitored by Virginia Tech faculty. There is also an equity-based reason to change the one-credit hour to zero-credit hours because domestic students might engage in co-op programs without telling the Graduate School but international students must tell the Graduate School of their co-op engagements in order to secure off-campus work authorization. This would also align graduate co-op credit with the current undergraduate co-op zero-credit-hour designation on a transcript.

Resolution to Establish a Master of Science Degree in Applied Data Science

Montasir Abbas presented the resolution for first reading. This resolution will establish a Master of Science degree in Applied Data Science. This degree combines methods, techniques, ideas, and learnings from statistics, computer science, and mathematics. There is currently a Bachelor of Science degree in Applied Data Science.
