3. Unfinished Business

Commission on Administrative and Professional Faculty Affairs Resolution CAPFA 2022-23A

Resolution to Revise the Administrative and Professional Faculty Senate Constitution

Janice Austin presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed.

Commission on Equal Opportunity and Diversity Resolution CEOD 2022-23B

Resolution to Approve the Land Acknowledgement and Labor Recognition Statements

LaTawnya Burleson presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed.

Commission on Administrative and Professional Faculty Affairs Resolution CAPFA 2022-23B

Resolution to Revise Chapter 7, Section 7, of the Faculty Handbook

Janice Austin presented the resolution for first reading. This resolution is specifically about the administrative and professional faculty grievance process. This revision will allow additional time for the administrative process.

Commission on Graduate and Professional Student Affairs Resolution CGPSA 2022-23A

Resolution to Expand and Secure Access to Reproductive Care at Virginia Tech

Alice Fox presented the resolution for first reading. This resolution has been revised from the original version that was distributed for comments to the senates. The current version adds an implementation committee to better look at every specific number and avenue to ensure all bases are covered. This resolution is intended to try to provide options for graduate and professional students at a low cost. The ballpark estimated cost for this will be an annual cost of \$520,000 and an initial cost of \$600,000 which would include hiring an additional OBGYN, hiring an ultrasound tech, and purchasing an ultrasound machine. Many graduate and professional students are either international students who do not have American health insurance or are over the age of 26 and have aged out of their parents' health insurance.

The president opened the floor for comments. The following points were made in the ensuing discussion.

A letter (attached) from a group of graduate students on campus who are invested in the preservation of Virginia Tech's commitment to a culture of safety was read asking for this resolution to be defeated.

A question was then raised as to whether this matter is appropriate to be considered in shared governance. One of the principles of shared governance clearly expresses that each constituent body within the university has a particular role and authority. There is a differentiation of function of the Board of Visitors, the university leadership, faculty, staff, and students. This particular matter is differentiated in its accountability and responsibility and should fall within the domain of university leadership. Matters that are substantively impacted by financial and logistical considerations fall within the domain of university leadership. An example of this is when decisions were made during the COVID pandemic. A suggestion was made that the governing documents should describes clearly what fits within shared governance.

University Council Cabinet determined that this resolution does fall within the charge of the Commission on Graduate and Professional Student Affairs, specifically the section of the charge that mentions matters related to graduate and professional student health and safety.

It was indicated that Schiffert Health Services provides care as one would receive from their primary care physician, and doesn't typically provide specialty care. The services provided are directly supported by the student health fees which creates limitations. Schiffert is accredited through ACHA which has standards for what basic services are covered. General health issues are covered in those standards and some specialized areas such as sports medicine. Other specialized areas are referred outside to a community specialist.

It was indicated that the University Council Cabinet should be providing guidance to constituent groups on what path to take for certain matters that are not appropriate for shared governance.

A suggestion was made to look at what the cost to the university is for an unwanted pregnancy such as when GTAs GRAs have to take leave from their work. Undergraduate students may have to leave the university due to an unwanted pregnancy which is also a loss of revenue.

Some undergraduate students have questioned how the student health fee is used. Some students have expressed concern that they do not wish for their fee to pay for these types of services.

Schiffert Health Services is an auxiliary and is fully supported by the student health fee, which also supports Hokie Wellness and Cook Counseling Center. The budget development process begins in the summer and is approved in June. Anything that is in this cycle has been vetted and approved. This resolution is not able to be implemented in this budget cycle but can be analyzed for a full set of options regarding reproductive care and family planning services.

A comment was made that it is becoming more common practice for primary care physicians to offer first trimester abortion care.

It was shared from the Staff Senate's Policy and Issues Committee that this resolution is to expand and secure reproductive care to ensure no gaps in reproductive care remain. With that said, the largest gap remains because there were no solutions expressed for those that elect to give birth.
