## 5. New Business

University Council
Resolution UC 2023-24A
Resolution to Revise the University Council Bylaws
Cyril Clarke presented the resolution for first reading. The new system of shared governance was approved in 2022 and included several new elements such as an expanded opportunity for engagement across the institution. One of the changes had to do with the creation of a University Council Cabinet. The cabinet has representation across the constituent representative bodies and is co-chaired by the Executive Vice President and Provost the and the Faculty Senate President. The overall goal of the cabinet is to facilitate and assist with streamlining the process of shared governance. The cabinet does not vote in terms of making a decision on any resolution, but it does have the opportunity to indicate whether or not a resolution falls within a commission's purview, but even in that case, that is something that is subject ultimately to the authority of University Council. When the new system of shared governance was established, it was recognized that this was a first attempt at a comprehensive approach and that as the new system is implemented, issues will be encountered that will need to be addressed. This resolution to amend the bylaws addresses some of those issues. One particular issue that came up initially is that the engagement and involvement of the University Council Cabinet was in fact delaying the process of review of resolutions. Other proposed revisions to the bylaws include simple housekeeping edits and changes to improve the efficiency of the system of shared governance.

At the conclusion of Cyril Clarke's introductory comments, a request was made by another member to include two supplemental documents that are being discussed in the University Council Cabinet in order to have a full discussion of the broader plan to change the constitution. In response, it was stated that Resolution UC 202324A that is before University Council for first reading today only addresses changes for the bylaws, and the constitution changes will be discussed at a later time since changes to the constitution are still in preliminary discussions in the cabinet. A concern was raised about a proposed change to Article III, Section 3 of the bylaws. The proposed change would eliminate the need to provide a draft resolution to the cabinet for review in order to determine if a resolution is within a commission's charge; instead, a one-page resolution proposal describing the concept for a resolution would be provided to the cabinet. It was then explained that the intention of this change is to streamline the process and save time since a resolution will not have to be written in advance for a commission to gain approval to move forward with a resolution. This will eliminate unnecessary work to draft a resolution that is not considered to fall within a commission charge by the cabinet. However, if the commission wishes to submit a full draft resolution to the cabinet along with the resolution proposal for determination as to whether it fits with a commission's charge, that would be permissible.

The chair agreed to allow the request to submit two supplemental documents, and they are attached to these minutes.

Chair's Note: These two documents are deliberative drafts currently or formerly under consideration by the University Council Cabinet, not the University Council. These documents (as submitted by cabinet member Rachel Maizel) represent the start of the shared governance process for revisions to the University Council Constitution that begins with discussion documents being deliberated within the cabinet and a formal resolution being drafted and approved by the cabinet before the resolution is shared with the senates for review and comment and then presented to the University Council for first reading. We are including these documents in the minutes at the request of Rachel Maizel. It is understood that these documents may evolve considerably before they reach the University Council for consideration. We hope that the transmission of deliberative documents does not suppress future open dialogue among cabinet members but understand that these documents were already leaked on social media.

## Scope of Shared Governance

It is not possible to anticipate every possible situation that may arise in order to define precisely what matters are within the scope of the university's shared governance system in contrast to those that may be considered operational or under the authority of the administration or the Board of Visitors. Generally, matters appropriate for policy development, revision, or discontinuance through shared governance are those that fall within the charges of the university and senate commissions as specified in the University Council Constitution.

However, consistent with the Virginia Tech Principles of Shared Governance pertaining to clarity of roles and authority and accountability, matters specifically excluded from the shared governance system include but are not limited to:

- Setting the university's legislative priorities
- Actions to comply with legal and regulatory requirements and directives from the Board of Visitors
- Personnel matters involving individuals, including but not limited to special awards, hiring decisions, promotion and tenure decisions, compensation decisions, disciplinary actions, non-reappointment decisions, severance actions, etc.
- Enrollment planning
- Budgetary decisions and other fiscal, investment, banking, and contractual matters
- Tuition and fees decisions
- Decisions regarding the university's organizational structure, such as the creation, realignment, or elimination of colleges
- Capital project decisions
- Campus master plan and subsidiary plans
- Real property/physical plant matters including acquisitions, demolition, easements, leases, renovations, sales, space planning and allocation decisions, etc.
- Services provided by the university such as housekeeping, dining, maintenance, health care, career services
- Matters involving the Virginia Tech Foundation, any of its subsidiary foundations, and any universityrelated corporations.
- Fundraising priorities and advancement activities including but not limited to fundraising, communications, and marketing
- Commemorative tributes
- Partnerships or affiliations with external entities
- Safety and security policy matters under the purview of the University's Safety and Security Policy Committee.
- Litigation and potential litigation
- Work of the Office of Audit, Risk and Compliance and the Office of Export and Secure Research Compliance
- Other operational matters and administrative policies promulgated by vice presidents and presidential policy memoranda. (Refer to www.policies.vt.edu.)

Questions arising about the appropriateness of a matter for shared governance will be settled by the University Council Cabinet upon consultation, if necessary, with the Vice President for Policy and Governance and Legal Counsel.

Matters not within the scope of shared governance may be communicated within the shared governance network for informational purposes.

# Proposed Changes - UC Constitution 

## Article II. Purpose -

Existing:
In order for this system to function as intended, the roles and authority of its different components as presented in this document must be maintained, and participants in shared governance are expected to adhere to these statements of purpose, function, or charge. Senate and commission charges identify the areas of legislative authority and responsibility for the relevant body. These charges are not exhaustive: when questions arise regarding the relevance of the topic of a resolution to a commission or senate charge, they will be addressed to the parliamentarian and, if necessary, the University Council Cabinet. Per Article III Section 3 of the University Council Bylaws, the University Council Cabinet will review all resolutions for agreement with the commission charge. Determination of the authority of a commission to advance a resolution rests with the University Council Cabinet and the University Council.

Proposed:

In order for this system to function as intended, the roles and authority of its different components as presented in this document must be maintained, and participants in shared governance are expected to adhere to these statements of purpose, function, or charge. Senate and commission charges identify the areas of legislative authority and responsibility for the relevant body. These charges are not exhaustive: when questions arise regarding the relevance of the topic of a resolution to a commission or senate charge, they will be addressed to the parliamentarian and, if necessary, the University Council Cabinet. Per Article III Section 3 of the University Council Bylaws, the University Council Cabinet will review all resolution proposals for agreement with the commission charge and appropriateness for the system of shared governance. At its discretion, University Council Cabinet may delegate limited authority to the Office of the Vice President for Policy and Governance to approve resolution proposals that clearly fall within a commission's charge, and the OVPPG will regularly inform the University Council Cabinet of all such decisions; University Council Cabinet retains veto power over all such decisions made by the Office of the Vice President for Policy and Governance. Ultimate determination of the authority of a commission to advance a resolution rests with the University Council Cabinet and the University Council.

## Article IV. Membership, Section 1. Composition

## Proposed:

Vice President for Outreach and International Affairs [since COIA is a university commission, as is CEOD, which already has a VP on University Council]
Four representatives elected by the Commission on Equal Opportunity and Diversity
One representative elected by the Commission on Outreach and International Affairs

Unless chairs of university and senate commissions are already serving on University Council through another affiliation, they will serve as ex officio, non-voting members of University Council concurrent with their term as commission chair to enable them to introduce and make a motion for approval of a resolution from their commission.

Revisions to the membership of the University Council follow the procedures for amendments contained in Article XIII of this constitution. Changes to titles of ex officio members of University Council or University Council Cabinet that are not accompanied by a significant role change may be made without following the amendment procedures.

## Article VI. University Council Cabinet, Section 3. Membership

Question: Membership of University Council includes the Department Heads Council Executive Committee co-chairs, and the Membership of the University Council Cabinet includes one representative of the Department Heads Council Executive Committee. Members of the Cabinet are required to be members of University Council or to attend University Council meetings. Would it make sense to change the representative on Cabinet to be one of the cochairs?

## Article VII Senates, Section 2. Functions -

Existing:
While senates have the right to consider any matter of general interest to their respective members and to seek wider discourse on these topics within our system of shared governance, concerns that fall outside senate or commission purviews as delineated in this constitution may not be advanced as resolutions.

## Proposed:

While senates have the right to consider any matter of general interest to their respective members and to seek wider discourse on these topics within our system of shared governance, concerns that fall outside senate or commission purviews as delineated in this constitution and/or outside the scope of University Council or otherwise inappropriate for the system of shared governance may not be advanced as resolutions.

## Article VIII. Commissions, Section 2. Responsibilities

Proposed - Add new paragraph at the end of the section, as follows:

In some cases, a commission may have other non-policy-making functions that do not involve or require approval of any senate or University Council. Such functions are stated explicitly in a commission's charge.

Charge: To study, formulate, and recommend to the Administrative and Professional (A/P) Faculty Senate policies and procedures affecting the working conditions of A/P faculty. Areas for consideration include morale of administrative and professional faculty; procedures for appointing, non-reappointing, evaluating, disciplining, recognizing, and promoting administrative and professional faculty; benefits, educational and personal leave, and extra-university professional activity; and matters of equity and diversity that affect $\mathrm{A} / \mathrm{P}$ faculty. The commission is also responsible for reviewing allegations of unprofessional or unethical conduct against any A/P faculty member and grievances advanced to the level of the executive vice president and provost or the vice president for human resources and for advising these administrators prior to their taking action.

Charge: To study, formulate, and recommend to the Administrative and Professional (A/P) Faculty Senate policies and procedures affecting the working conditions of $A / P$ faculty. Areas for consideration include morale of administrative and professional faculty; procedures for appointing, non-reappointing, evaluating, disciplining, recognizing, and promoting administrative and professional faculty; benefits, educational and personal leave, and extra-university professional activity; and matters of equity and diversity that affect $A / P$ faculty.

Areas for consideration include undergraduate student wellbeing, inclusion, and morale; undergraduate student relations with peers, staff, faculty, administrators, alumni, and the community; policy matters related to undergraduate student conduct; undergraduate student organizations, social life, and recreation; employment and placement; residential and campus life; and undergraduate student well-being. The Commission on Undergraduate Student Affairs also approves the constitutions of all University Chartered Student Organizations (UCSOs) except the student senates; this function does not involve or require approval of any senate or University Council.

## Article XII. University Mission Initiatives

In spring 2023, University Council Cabinet was asked to consider a matter for consideration as a university mission initiative. After much discussion, Cabinet determined that the matter was already in implementation phase and thus not appropriate for the UMI process. However, it was the consensus of Cabinet members that this section of the UC Constitution needs to be revised and expanded upon to include more guidance (i.e., specific criteria and examples) to enable them to make a determination in the future as to whether a matter is appropriate for the UMI process.

Proposed: It is recommended that a small committee including some individuals who were part of the creation of the UMI concept be involved in that revision process.

## Article XIII. Amendments to the University Council Constitution or Bylaws, Section 3. Approval of Amendments to the Bylaws

An amendment to the University Council Bylaws becomes effective upon an affirmative vote of the majority of the Council members present and voting, provided that a quorum has been reached, and approval by the president.
