Resolution to Revise the University Council Constitution

4. New Business

Commission on Graduate and Professional Student Affairs
Resolution CGPSA 2023-24A
Resolution to Protect Against Caste & Caste-Based Discrimination

Ranald Adams presented the resolution for first reading. Virginia Tech's current anti-discrimination policy does not explicitly cover caste and caste-based discrimination. This resolution will update Policy 1025 to include protection against caste-based discrimination and will add a definition of caste to the policy.

A deferral was requested to give the Commission on Equal Opportunity and Diversity (CEOD), the Office for Equity and Accessibility (OEA), and the university legal counsel an opportunity to review and discuss the resolution.

Although members of GPSS or CGPSA had reached out to OEA and CEOD in recent months, the consultation with OEA occurred before the resolution was developed, and CEOD has not yet discussed the resolution but plans to do so at its next meeting. CEOD's charge includes policy matters related to diversity and inclusion, and that commission has a long-standing request to be consulted on any such resolutions that do not originate in CEOD. The Commission on Graduate and Professional Student Affairs was previously unaware that university legal counsel review was necessary.

It was stated that the Office of Equity and Accessibility (OEA) has institutional compliance responsibility as it relates to Policy 1025, and OEA has determined that the language in Policy 1025 as it relates to non-discrimination categories is broad and interpreted to be inclusive of caste. OEA is also in the process of rolling out a revised training program for Policy 1025 which will state explicitly that the prohibition of discrimination on the basis of national origin includes caste discrimination.

A suggestion was made to include caste in the current policy just to make sure that it doesn't get overlooked even if the current language is inclusive of caste discrimination.

There being no further discussion, the resolution is deferred and will be brought back for second reading and vote no later than the May 6, 2024, meeting. The expectation is that CGPSA will be consulting with the following people/entities to ensure that the resulting resolution and proposed changes to Policy 1025 will be considered satisfactory by CGPSA as well as:

- CEOD – Melissa Faircloth/Stacey Wilkerson.
- Office for Equity and Accessibility - Kelly Oaks
- University Legal Counsel - Kay Heidbreder. Although attorneys are employed throughout the university in various capacities, the attorneys in the Legal Counsel office also are special assistant attorneys general, and it is that office that has the responsibility for providing legal advice to the university.
