Commission on Research COR Resolution 2024-25A Resolution to Clarify Eligibility for Postdoctoral Associate Status

Commission on Undergraduate Student Affairs CUSA Resolution 2024-25B Resolution to Amend the Undergraduate Student Senate Constitution

Since the first reading, only one change has been made in response to feedback from the Staff Senate. For the purpose of this resolution, the definition of "college" was revised to reflect the inclusion of more colleges and programs than previously listed. The updated definition states: "A USS college senator is a USS senator representing a college, part of a college, or other significant academic or academic adjacent program." This revision ensures that core senators and future positions, such as intercollege senators, are appropriately represented as college senators. A vote was taken, and the motion passed.
