November 1, 2021: First reading of Commission on University Support: Resolution to Change Membership to the Transportation and Parking Committee; and presentation by Dr. Daniel Sui, gave a presentation on the history and characteristics of members of the Association of American Universities (AAU).

<u>Nov 15, 2021:</u> Second reading and vote of Commission on University Support: Resolution to Change the Membership of the Transportation and Parking Committee. First reading of Commission on Faculty Affairs: Resolution to Revise Faculty Handbook Section 2.17.12 Related to Change of Duty Station and Special Leave; Commission on Undergraduate Studies and Policies: Resolution to Approve New Major, Commercial Development and Investment, in Bachelor of Science in Real Estate; Commission on Undergraduate Studies and Policies: Resolution to Approve New Major, Residential Development and Investment, in Bachelor of Science in Real Estate; Commission on Undergraduate Studies and Policies: Resolution to Approve New Major, Financial Planning and Wealth Management, in Bachelor of Science in Business in Finance

- B. Virginia Cooperative Extension (VCE): Ben Grove announced the VCE winter conference will take place the week of January 29, 2022 at the Inn at Virginia Tech and Skelton Conference Center. The professional conference occurs annually. Ben also announced the Virginia Agricultural and Natural Resources Summit led by the College of Agriculture and Life Sciences, Virginia Cooperative Extension, and Virginia Agricultural Experiment Station is planned for April 2022. The goal is driving public-private partnerships in the agriculture and natural resources sectors and the focus of the summit is expanding the economy and security of Virginia's agricultural and food systems. This is a follow up to the 2018 summit and is an opportunity to engage primary stakeholders in higher education, Extension, government, and industry. Dr. Ed Jones announced that he will be retiring as director of VCE after serving for more than ten years. A national search for a new director will take place and Dr. Jones will continue to lead the organization until the new director is in place.
- C. University Committee on International Affairs (UCIA): Theresa Johansson reported on the October 25, 2021 UCIA meeting. The meeting included election of the vice-chair, Farida Jalalzai, who will be leading the selection committee of the Alumni Awards for International Education, Outreach and Research. Nicole Sanderling gave an update on the data commons application; the next UCIA meeting will be held this coming Monday, November 22, 2021. UCIA has set forth goals in order to align with COIA's priorities; three (3) working groups have been established; International MOU Process & Database; Global Advancement and Alumni; and Internationalization at home. A motion was made to update the UCIA bylaws with regard to membership.
- **D.** Global Alumni Engagement Sub-Committee Update: There have not been any new meetings at this time.
