- Commission on Graduate and Professional Studies and Policies Resolution CGPSP 2021-22D Resolution to Institute a Living Wage for Graduate Students was presented for the second reading.
 - The end result after a lengthy discussion, and several proposed amendments, is that the official second reading was deferred to the next UC meeting.

 - University Council Resolution UC 2021-22B Resolution to Rename the College of Architecture and Urban Studies

8) Old Business

- a. CSA Resolution 2021-22E for Approval of Undergraduate Student Senate Governing Documents was presented for the second reading.

 - Staff Senate endorsed, but had editorial comments
 - o Administrative and Professional Faculty Senate also endorsed, but shared editorial comments
- Juwan Jacobs shared that he and Bob Hickok were scheduled to meet on Friday, March 18. At which time they will work together to double check the updated numbering of all crossed referenced articles and such, to ensure accuracy and transparency. In addition, they will work on the editorial recommendations received by the senates.
- A motion is made to approve the resolution, upon the above stated conditions. The motion is seconded. A vote was taken on the motion, and the motion passed unanimously.







Combined SBB & GSBB: 2/18 - 3/16





First the Table of Contents lists Article III as being the Cabinet but in actuality it is the Definitions article and Article IV is the Cabinet. Additionally, there are two places that are labelled Article IV (Cabinet and Senators) in the Bylaws (pages 5 and 13) and this messes up the numbering of the subsequent Articles. Consequently, any references made throughout the document to a certain article and section number will need to be checked for correctness that this article and section number is the correct one for what is being referenced.
