Mr. Wehner proposed that Lori Baker-Lloyd attend a CAPFA meeting to discuss opportunities for employee development and the current climate survey. He also reported that President Sands has begun the process of searching for a Vice President for Human Resources discussed a proposed restructuring of Human Resources to decentralize the function, similar to the model currently used in CALS.

Ms. Brogdon discussed AP faculty's involvement in Beyond Boundaries and how we could become more involved, particularly in relation to our colleagues across the state.
