PRESENTATION: Ennis McCrery and Tamara Cherry-Clarke, Changes to the Code of Student Conduct

Ennis McCrery and Tamara Cherry-Clarke gave an informative presentation on the transformation of the Hokie Handbook to an online and accessible Code of Student Conduct. They see themselves as educators, not disciplinarians, and the new format shows this by updating rules such as "No climbing the buildings" and "No throwing snowballs out the windows" to "Do not cause harm to yourself or others." Communication with the Student Conduct office is more accommodating to both complainants and respondents, especially for those whom English is not a first language, and scheduling of meetings is more flexible.

The commission very much appreciated hearing this update.

OTHER BUSINESS

Discussion ensued about the disproportionate impacts of COVID-19 on persons who were already marginalized. Support for women, many of whom are now caregivers, domestic workers, and homeschool teachers in addition to their full time work, is lacking. There was a question about whether the tenure clock will be extended for tenure-track faculty, and apparently it will. It was noted that economic impacts on low-income students are felt more harshly. Impacts on international faculty, especially those with long-term research abroad, are unknown.

- I. Presentation by Student Conduct
 - A. All students, all campuses, all non-academic cases
 - B. Top policy violations include alcoholic beverages and university policies violations
 - C. Title IX- smallest percentage, heaviest, and most time-consuming
 - 1. All mandated reporters
 - 2. Oversee adjudication of cases, coordinate hearings
 - 3. 35 students referred (49% found responsible for violating a gender-based policy)
 - 4. Types of policies violated include dating and domestic violence, gender-based harassment
 - Question about new DOE guidelines and how this impacted guidelines at VT- no real change fo now, waiting for updated guidance from DOE that will come in the future
 - D. Updates/changes in policies and procedures
 - 1. Gender based cases are treated equitably
 - 2. Sanction enhancement for policy violations motivated by bias (adopted 6/19); snippet shared with CEOD previously
 - 3. Attention to accessibility; print document, accommodations, etc.
 - 4. Work to make sure processes were as equitable and inclusive as possible (e.g. zoom meetings, time of day for meetings, websites in terms of accessibility, lessening guidelines around requesting accommodations; interpreters, etc.)
 - 5. Representative on Bias Incident Response Team
 - 6. Question- Have you had incidents of inappropriate zoom usage, zoombombing, harassment? They have put out information on how to report, haven't had many reports so far, have had a report from another institution about a VT student
 - E. Code of Conduct Revision
 - 1. Started revising code of conduct and Hokie handbook
 - 2. Changes include moving to a stand alone Hokie handbook
 - 3. Format has changed, more bullets
 - 4. Restorative justice approach
 - 5. Simplifying policies for clarity
 - 6. Question about meaning of expungement- would not be releasable, provide language that some records are expunged, discussing with legal counsel

IV. Caucus Updates

- A. Women's Alliance-
 - 1. Support systems are gone or lacking due to pandemic, would like university to acknowledge this (e.g. tenure process)
 - 2. Concerns about how to capture this story and how to get administrators to work on this
 - 3. Comment- Faculty can ask for extension in tenure process
 - 4. Concerns that productivity could impact futures of positions

B. Other comments:

- 1. Concerns about disproportionate impact of pandemic on people of color, uncertain if university can do anything to recognize this or assist with
- URM and low income populations will be affected. Concerns about students coming back back. CARES Act funding provides some cushion but will probably still need greater financial assistance
- 3. Hiring freeze doesn't apply to student wage employees
- 4. International faculty have concerns about impact of pandemic on their work.

 Concerns about executive order to stop immigration which was announced last night.
