Resolution to Approve the 2020-2021 Student Code of Conduct and to Retire the Hokie Handbook

Victoria Dashevsky introduced the resolution for first reading and made a motion for first reading and action (commonly referred to as "waiver of first reading"). The motion was seconded. A vote was taken and the motion for action passed. A motion was then made by Victoria Dashevsky to approve the resolution itself, and the motion was seconded. Victoria Dashevsky informed the council membership that the new format for the Student Code of Conduct will help students better understand what is expected of them at Virginia Tech, and she then introduced Ennis McCrery, Director of Student Conduct, to answer any questions. Although the resolution was reviewed by the Graduate Student Assembly; Karen DePauw noted that the Commission on Graduate and Professional Studies and Policies may want to propose some changes for the subsequent version of the Code of Conduct. Ennis McCrery indicated that when she met with the Graduate Student Assembly, they discussed having a meeting next year to discuss further revision to the Code to address graduate student concerns. She added that a communication strategy will be developed to direct students where to find the code of conduct and any policies that were originally located in the Hokie Handbook. A vote was taken, and the motion passed.

5. Presentation on Date of Entry Change and the Registration Life Cycle

Rick Sparks, Associate Vice Provost and University Registrar, gave a presentation on the date of entry change and the registration life cycle. (presentation attached).

6. Announcements

Dr. Sands gave an update on the planning that is going on at the university to address the COVID-19 pandemic. The Board of Visitors will have a series of committee meetings virtually throughout the month of May leading up to a full virtual board meeting on June 2, 2020.

The Governor and General Assembly have decided to defer the decision on budget cuts and/or adjusting allocations to universities. The Governor has directed that discretionary spending and new hiring should be limited. Prior to the COVID-19 crisis, the State of Virginia was in a good position financially, and the state has a significant rainy-day fund. The Governor will request a reforecasting of state revenues in late July or early August, after which Virginia Tech should receive guidance regarding appropriations for FY2021. Virginia Tech has asked units to work on 5 percent and 10 percent reduction plans. These are just plans until the state determines what the situation will be going forward.

President Sands stated that fall enrollment and tuition revenue are uncertain. Currently international enrollment is soft due to travel restrictions and difficulties obtaining visas with many consulates closed. Hopefully some of these concerns will be resolved over the next several weeks. President Sands expressed optimism about enrollment for the fall. Virginia Tech has maintained direct communication with current students and potential incoming students in order to assure them that Virginia Tech will be as flexible as possible during this crisis.

The federal CARES Act funding has been allocated, and Virginia Tech is in the process of disbursing \$9.7 million for student aid. The student emergency fund is doing pretty well. The Dean of Students Office is the point of contact for undergraduate, graduate, and professional students who have financial need due to the

crisis. In response to a question about graduate assistantships that will lapse in the summer, President Sands explained that it will cost approximately \$1 million to extend graduate assistantships by one month. There currently is not a plan to cover systematically all graduate students on assistantships, but they are being reviewed on an individual basis as needed.

It was suggested that since some graduates have had job offers rescinded or have decided to delay their job search, there may be an increased interest in enrolling in graduate school.

There have been discussions regarding the varying instructional options for the fall semester such as face-to-face, online, or a mixed approach. President Sands was asked whether the following options were being considered:

- Larger classrooms for large classes
- Beginning the fall semester online and switching to face-to-face at a later date
- Delaying the start of the fall semester

Provost Clarke indicated that planning for the fall continues, and different stakeholders and constituent groups will continue to be engaged in the process. This week, there will be conversations with the Department Heads Executive Council, the Academic Affairs Council, and the Faculty Senate Cabinet. Virginia Tech is soliciting and receiving rich and well-informed input. Planning is predicated on the understanding that while our faculty have been enormously successful in pivoting to online classes this spring, a lot of the reputational excellence associated with Virginia Tech, especially in regards to experiential learning, requires that we make every effort to have in-person classes this fall. To accomplish an in-person fall while suppressing any resurgence of COVID-19, public health measures such as sanitization, barrier protection equipment, and a robust system of testing for COVID-19 will need to be utilized. He added that there have been discussions around delaying the start of the fall semester, but there seems to be no benefit to doing so.

There being no further business, a motion was made to adjourn the meeting at 4:26 p.m.










