Commission on Graduate and Professional Studies and Policies Resolution CGPSP 2020-21E

Resolution to Rename the Department of Interprofessionalism in the VTCSOM to the Department of Healthcare Innovation and Implementation Science

Commission on Student Affairs Resolution CSA 2020-21B

Resolution to Approve the Establishment of an Undergraduate Student Senate (USS)

Miles Guth presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed. [Note: The actual Undergraduate Student Senate Constitution and Bylaws will be drafted and submitted for approval through the governance system during the 2021-22 academic year.]

Commission on Student Affairs Resolution CSA 2020-21C

Resolution to Amend in its Entirety the Constitution of the Graduate Student Assembly and Reenact as "The Constitution of the Graduate and Professional Student Senate"

Miles Guth presented the resolution for second reading and made a motion to approve. Ben Beiter from the Graduate Student Assembly Judicial Branch indicated that after receiving feedback during the first reading of the resolution some minor changes have been made to the Graduate and Professional Student Senate Constitution. A transition team, which will include the newly elected executive board, has been created to address any further issues over the summer. One item the transition team will be reviewing is the timing of elections for the executive board. The motion was seconded, and the motion passed.

Commission on Undergraduate Studies and Policies Resolution CUSP 2020-21J

Resolution to Establish Continuous Enrollment Policy for Undergraduate Students

Paul Deck presented the resolution for second reading and made a motion to approve. After first reading, based on feedback, a few changes were made in the resolution (highlighted in yellow) that was sent out to the University Council membership prior to this meeting. The name of the resolution was changed from "Resolution to Establish a Readmission Policy for Undergraduate Students" to "Resolution to Establish a Continuous Enrollment Policy for Undergraduate Students," to better reflect what the purpose of the policy is in a positive light. This wording was also changed in one of the whereas statements. Also, based on advice from University Legal Counsel and Student Affairs, language was added stating that students who are suspended from the university due to a student code of conduct sanction will automatically be re-enrolled per sanction terms; students do not need to take any action to return to active status after being suspended from the student code of conduct. The motion was seconded, and the motion passed.
