Commission on Faculty Affairs Resolution CFA 2020-21A (deferred October 19, 2020) Resolution to Revise Faculty Handbook Promotion and Tenure Guidelines

Bob Hicok presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed.

Resolution CFA 2020-21B (deferred November 2, 2020) Resolution to Revise Chapter 5 of the Faculty Handbook: Employment Policies and Procedures for Non-Tenure-Track Instructional Faculty Bob Hicok presented the resolution for second reading and made a motion to approve. The motion was seconded, and the motion passed.

4. New Business

Commission on Research Resolution COR 2020-21A

Resolution to Establish a Scholarly Articles Open Access Policy

Rajaram Bhagavathula presented the resolution for first reading and introduced Ginny Pannebecker and Philip Young to give an overview of the policy and answer any questions. The work on this policy started in 2016 with a subcommittee working with the Commission on Research. The committee reached out to the university community to get feedback which led to several revisions to the policy. This policy was originally a standalone policy but has since been incorporated into policy 13000 as part of Virginia Tech's intellectual property guidance.

A question was raised as to whether any thought has been given to creating a similar repository for other forms of non-standard research outputs that Virginia Tech produces such as designs and artworks. Virginia Tech currently has two repositories. The VTechWorks Institutional Repository focuses on scholarly articles, but any type of research or scholarship one wants to share publicly can be added to this repository. There is a separate repository for research data, VTechData repository, which has elements that work best for sharing data as a group of files. In the committee's research of other universities, their policies did not extend beyond scholarly articles.

Resolution to Approve New Degree, <u>Bachelor of Arts in Education in Secondary Education</u>, and New Major: English Language Arts Education, and History and Social Sciences Education, and New Degree, <u>Bachelor of</u> <u>Science in Education in Secondary Education</u> with New Majors: Mathematics Education, Career and Technical Education – Agricultural Education, and Career and Technical Education

Paul Deck presented these two resolutions for first reading and introduced Dawn Knight to respond to specific questions about the proposals. Approximately 10-15 years ago the emphasis changed across the state to encourage teachers to become more proficient in their chosen content area and to major in areas in which they planned to teach rather than in education. There is a pressing need for more teachers in the Commonwealth of Virginia and across the nation. A couple of years ago there was new legislation passed that once again allowed four-year institutions to have majors in education. The institutions in Virginia are re-establishing those four-year education degrees, enabling students to take courses in their content area along with their pedagogy courses at the same time.

There is a demand from current students to complete their course work in four years, and this new degree will answer that demand as well as aid in recruitment of new students who may not have considered Virginia Tech.






Bob Broyden, Associate Vice President for Campus Planning and Capital Finance, gave a presentation on the planning and prioritization of facilities improvements (attached).


7. Adjournment-
